### **Eligibility**

- Purchase and install an Energy Star Level 2 EV Charger within the past 12 months.
- Crystal Falls Electric Department electric customer whose account is in good standing.
- EV charger installed on an electric meter billed under a Crystal Falls Electric Department electric service rate.
- Own or Lease a registered EV that can receive a Level 2 charge.
