MyAccount Mobile App!

The MyAccount mobile app is now available to download for either iOS or Android users. This version of the app allows customers to view their usage, view their bill and bill history, pay their bill, set alerts and more. All customers that use MyAccount are able to access the app as follows:

1. Download the 'MyMeter' app for iOS and Android
2. Open the app and select 'City of Crystal Falls' from the menu. This choice will become the default for every future use.
3. Log in with existing credentials or create a new account if you have not already done so in MyAccount.

Note: This is only available to active utility accounts.

Ordinance Fines and Costs

Grass: 12 days to correct the violation. If not corrected the City of Crystal Falls will cut the grass at the land owners expense. 1st offense: \$100 plus court costs; 1st repeated offense: \$250 plus court costs; 2nd repeated offense no less than \$500 plus costs.

Junk Car: Must be made to be in compliance, removed or stored within a totally enclosed garage within 30 days of notice. 1st offense: \$100.00 plus court costs; 2nd offense: \$250.00 plus court costs. Subsequent offenses: No less than \$500.00 plus court costs.

Blight: Must be in compliance within 12 days of notice of violation. 1st offense: \$100.00 plus court costs. 2nd offense: \$250.00 plus court costs. Subsequent offenses: No less than \$500.00 plus court costs.
